Extra Benefits You "Deserve": Yes, you should have as many additional benefits as possible! It is important to note that Dental, Vision, Hearing, Transportation and Gym benefits vary widely from plan to plan, and region to region. If you have questions about whether or not your current plan includes these benefits please call, and I will review your plan's benefits with you.

This commercial promises all these potentially wonderful features and benefits for one reason... so you CALL them. Then they can change your plan and earn a commission.
